RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS ("Release") is made and effective as of November 25, 2020 ("Effective Date") and is granted by CIBC Bank USA (formerly known as The PrivateBank and Trust Company, "Secured Party"), in favor of Electrix, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to the Financing Agreements, the Grantor executed and delivered to Secured Party that certain Patent Security Agreement, dated as of December 23, 2016, by and among Grantor, Evolution Lighting, LLC, a Delaware limited liability company ("Evolution Lighting"), and Secured Party (including all annexes, exhibits or schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified, the "Patent Security Agreement").

WHEREAS, pursuant to the Patent Security Agreement, Secured Party is the holder of a continuing security interest in all of Grantor's right, title and interest in all Patents owned by Grantor, including, without limitation, the Patents owned by Grantor that are listed on Schedule A pursuant to the Patent Security Agreement (as from time to time amended, restated, supplemented or otherwise modified).

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office.

WHEREAS, Grantor has requested that the Secured Party enter into this Release in order to effectuate, evidence and record the release and termination of any and all right, title and interest the Secured Party may have in the Patents owed by Grantor pursuant to the Patent Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Secured Party agree as follows:

1. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.

2. Secured Party, its successors and assigns, hereby terminates the Patent Security Agreement solely with respect to Grantor, but not Evolution Lighting, and forever unconditionally, expressly and irrevocably releases, terminates and discharges all security interests that the Secured Party has pursuant to the Patent Security Agreement in, to and under all Patents owned by Grantor, including, without limitation, the Patents listed in **Schedule 1** hereto, all divisionals, continuations, continuations-in-part, reissues, reexaminations or extensions of the foregoing; and all claims or causes of action arising out of or related to any past, present or future infringement or other violation of any of the foregoing throughout the world, including, without limitation, rights to recover for past, present and future violations thereof and any and all proceeds of the foregoing.

3. Secured Party hereby authorizes and requests (a) the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Patent Security Agreement and the Patents owned by Grantor and (b) any other state,

federal and/or foreign government agency to record this Release with regard to the Patent Security Agreement and the Patents owned by Grantor.

4. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Illinois, without giving effect to any choice or conflict of law provision or rule (whether of the State of Illinois or any other jurisdiction).

5. This Release may be executed in multiple counterparts, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.


