TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of December 4, 2020 by **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 505 Howard Street, Floor 3, San Francisco, California 94105 (“**Bank**”), in favor of **SIDE, INC.**, a Delaware corporation (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of July 29, 2020 (the “**Agreement**”), granting to Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Intellectual Property Collateral, including, without limitation, the Patents (as each such term is defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (the “**USPTO**”) on July 30, 2020, at Reel 053362, Frame 0106.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, Grantor has requested that Bank provide a document suitable for recording with the USPTO to evidence the release of Bank’s security interests in and liens on the Patents as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby:


1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, those patents and patent applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
