## INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT

THIS INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT (this "**Assignment**") is made and delivered effective as of the 2nd day of November, 2020, by and between Fast Global Solutions, Inc., a Minnesota corporation ("**Seller**"), and FGS Ag Acquisition Company LLC ("**Buyer**").

### RECITALS

WHEREAS, Seller, Buyer, and certain other parties have entered into that certain Asset Purchase Agreement dated November 2, 2020 (the "**Purchase Agreement**"), pursuant to which Buyer has agreed to purchase and Seller has agreed to sell the Purchased Assets described in the Purchase Agreement; and

WHEREAS, the Purchase Agreement provides that Seller and Buyer are to enter into this Assignment, providing for the assignment from Seller to Buyer, of all of Seller's right, title and interest in, under and to the Intellectual Property Assets (as defined in the Purchase Agreement) of Seller, inclusive of trademarks, trade secrets, know-how and domain names, on and subject to the terms of the Purchase Agreement.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and intending to be legally bound, the parties agree as follows:

1. Definitions. Unless otherwise defined herein, capitalized terms used in this Assignment without definition shall have the meanings ascribed to them in the Purchase Agreement.

2. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers and assigns to Buyer, and Buyer accepts, all of Seller's right, title and interest in and to the Intellectual Property Assets, except for the Excluded Assets, including, without limitation, the following Intellectual Property Assets:

(a) the patents and patent applications set forth on Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof;

(b) all rights of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable Law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

3. No Other Representations. Except as set forth in the Purchase Agreement, Seller makes no representation or warranty regarding the Intellectual Property Assets.

4. Execution and Delivery; Further Assurances. This Assignment is executed pursuant to and supplements the Purchase Agreement and is in furtherance of the sale and transfer of the Purchased Assets. The terms of the Purchase Agreement apply to this Assignment. To the extent any term or provision herein is inconsistent with the Purchase Agreement, the terms and provisions of the Purchase Agreement shall control. Seller agrees to execute and deliver all papers, instruments and assignments and to perform any other reasonable acts Buyer may require in order to vest all right, title and interest in and to the Intellectual Property Assets, except for the Excluded Assets, and any related rights to Buyer and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Seller.

5. Successors and Assigns. This Assignment will apply to, be binding in all respects upon and inure to the benefit of the successors and permitted assigns of the parties.

6. Severability. If any provision of this Assignment is held invalid or unenforceable by any court of competent jurisdiction, the other provisions of this Assignment will remain in full force and effect. Any provision of this Assignment held invalid or unenforceable only in part or degree will remain in full force and effect to the extent not held invalid or unenforceable.

7. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Iowa, regardless of the laws that might otherwise govern under applicable principles of choice or conflicts of law thereof.

8. Counterparts. This Assignment may be executed in several counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument, and shall become effective when counterparts have been signed by each of the parties and delivered to the other parties; it being understood that all parties need not sign the same counterparts.
