
Patent Office to issue Canadian patent(s) from said Canadian patent application in accordance with this Assignment.

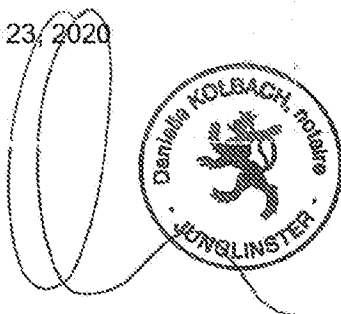
