PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of December 16, 2020, by LEVINE LEICHTMAN SMALL BUSINESS FUND, L.P. (formerly known as Levine Leichtman Capital Partners SBIC Fund, L.P.), as Administrative Agent for the Lenders ("Administrative Agent").

WITNESSETH:

WHEREAS, Administrative Agent and Pacific Handy Cutter, Inc., a California corporation ("Grantor"), were parties to that certain Patent Security Agreement, dated as of January 30, 2018 (the "Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Administrative Agent in the Patent Collateral, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Patent Office ("USPTO") on February 1, 2018, at Reel 045215, Frame 0766;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Patent Collateral and reassign the same to Grantor; and

WHEREAS, Administrative Agent has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Patent Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the Patent Collateral, including the following:

(a) all of its patents and rights in and to exclusive intellectual property licenses with respect to patents to which it is a party including those patents referred to on Schedule I hereto;

(b) all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations of and amendments to the foregoing; and

(c) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement of any patent or any patent licensed under any intellectual property license or (ii) right to receive license fees, royalties, and other compensation with respect to any of the foregoing.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest (if any) in and to the Patent Collateral.


