I also request the Commissioner of Patents and Trademarks to issue any Letters Design Patent of the United States which may be issued for said invention to Jiangmen Foreign Trade Group Co., Ltd., its legal representatives, successors or assigns, as the sole owner of the entire right, title, and interest in said design patent and the invention covered thereby.
