TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this “Termination”), is dated as of December 31, 2020 and made by **ACCEL-KKR CREDIT PARTNERS SPV, LLC**, as administrative agent for each member of the Lenders (in such capacity, together with its successors and assigns in such capacity “Agent”), in favor of **VOBILE, INC.**, a California corporation (the “Grantor”).

WHEREAS, pursuant to that certain Patent Security Agreement dated as of November 15, 2019 executed by Grantor in favor of the Agent (the “Security Agreement”), a security interest was granted by the Grantor to the Agent in, all of its right, title and interest in, to and under the Patent Collateral (as defined therein), including, without limitation, those Patents referred to on Schedule A hereto;

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on November 19, 2019 at Reel/Frame 051036 / 0637; and


WHEREAS, the Agent now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and not otherwise defined herein have the meanings specified in the Security Agreement.
2. Release of Security Interest. The Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Patent Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of the Agent in the Patent Collateral.
