
WHEREAS, the following applications for United States Letters Patent were filed:

WHEREAS, MEDTRONIC VENTOR TECHNOLOGIES LTD. (hereinafter "ASSIGNEE"), a corporation organized and existing under the laws of the State of Israel and, and having its principal place of business at 3 HaCarmel Street, Yokneam Elit, Israel, owns the entire right, title, and interest in and to the invention(s) disclosed in said applications and any and all patents that may be obtained therefor, and in and to said applications and any and all patents that may issue therefrom;

NOW, THEREFORE, MEDTRONIC VENTOR TECHNOLOGIES LTD. states that on or before January 23, 2007, the inventors transferred the entire right title and interest in the invention and above-referenced applications to Ventor Technologies, Ltd. by assignment of U.S. Provisional Application No. 60/852,435, recorded herewith. In December 2010, the inventors purported to sign a second assignment of U.S. Application No. 12/445,824, which descends from the above-referenced applications to Medtronic-Corevalve, Inc. This second assignment is ineffective to transfer title to the invention to Medtronic-Corevalve, Inc. as the inventors had nothing to assign. Thus, the proper title remains in Medtronic Ventor Technologies Ltd. the successor to Ventr Technologies Ltd., as recorded, for example, at Reel, Frame 022542/0176 in the USPTO.
