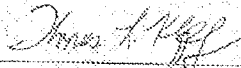
(Changing the Name of the Organization to Revolution Cooking, LLC)

ARTICLE ONE: The name of the company (which is hereinafter called the "Company") is Revolution Cooking, LLC.

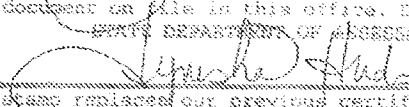
