Termination and Release of Security Interest in Patents**

Termination and Release of Security Interest in Patents (this “Agreement”) dated as of December 9, 2020, from Valkendaal B.V., as collateral agent for the holders (the “Holders”) of a series of Convertible Promissory Bridge Notes having a combined total original principal amount of up to \$800,000 issued by LV Investors LLC and LV Investors International LLC, and in its capacity as the Secured Party under a Security Agreement dated as of December 10, 2018 (the “Secured Party”), between the Secured Party and LV Investors LLC, LV Investors International LLC, LaVit Life LLC (now known as Lavit LLC), and La Vit Technology LLC, each a Delaware limited liability company (Lavit LLC and Lavit Technology LLC each a “Grantor” and collectively the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to a Patent Security Agreement, dated as of December 10, 2018 (the “Patent Security Agreement”), the Grantors granted to the Holders and to the Secured Party, for the benefit of the Holders, and for the benefit of the Secured Party in its capacity as collateral agent for the Holders, a security interest in all of each Grantor’s right, title and interest in, to, and under the Patent Collateral (as defined in the Patent Security Agreement) (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Patent Security Agreement, as applicable);

WHEREAS, the Patent Security Agreement was recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office (the “USPTO”) on December 12, 2018 at Reel 047759, Frame 0606.

WHEREAS, the Secured Party now wishes to release its liens on, and security interests in, the Patent Collateral in the Patent Security Agreement, including, without limitation, the patents as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Secured Party hereby states as follows:

1. Release of Security Interest. The Secured Party hereby terminates, releases and discharges all of its security interest in the Patent Collateral, and reassigns any and all right, title, and interest that it may have in or to the Patent Collateral to the Grantors.
2. Recordation. The Grantors and their authorized agents are authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of Delaware, U.S.A., without regard to conflicts of laws principles.
4. Further Assurances. The Secured Party shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantors, and at the Grantors’ cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
