**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of December 23, 2020, is made by Antares Capital LP, in its capacity as administrative agent (in such capacity, the “Administrative Agent”) for the Secured Parties (as defined in the Collateral Agreement (as defined below)), in favor of Reno A&E, LLC, a Delaware limited liability company, Ennis Paint, Inc., a Texas corporation, Flint Trading, Inc., a North Carolina corporation, Eberle Design, Inc., an Arizona corporation, and American Traffic Products, Inc., a California corporation (collectively, the “Grantors”), as follows:

WHEREAS, pursuant to that certain First Lien Collateral Agreement, dated as of June 13, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), by the Grantors and the other parties party thereto in favor of the Administrative Agent, for the benefit of the Secured Parties, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements” and, collectively with the Collateral Agreement, the “Security Agreements”), the Grantors granted a security interest (the “Security Interest”) in certain collateral in favor of the Administrative Agent, for the benefit of the Secured Parties, including the IP Collateral (as hereinafter defined); and

WHEREAS, the applicable Grantors now request that the Administrative Agent terminate, release and discharge the IP Security Agreements and the entirety of its Security Interest in the IP Collateral (as defined below), including the Trademarks, Patents and Copyrights described on Annex II attached hereto, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. Definitions. The term “IP Collateral”, as used herein, shall mean all of the Grantors’ right, title and interest in, to and under the Trademarks, Patents and Copyrights (a) listed on Annex II attached hereto or (b) otherwise granted pursuant to or subject to the Security Agreements. Capitalized terms not defined herein have the meanings set forth in the Security Agreements, as applicable.

2. Release of Security Interest. The Administrative Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its Security Interest in and to the IP Collateral and the IP Security Agreements and any and all right, title and interest of the Administrative Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Administrative Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable, at the sole expense of the Grantors, to

evidence and effectuate the release and termination of the Administrative Agent's Security Interest in the IP Collateral.

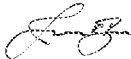
