Pursuant to Title 8, Section 252 of the Delaware General Corporation Law (the "DGLA"), the undersigned corporation hereby executed the following Certificate of Merger:

1. The name of the surviving corporation is Medtronic, Inc., and the name of the corporation being merged into this surviving corporation is Tyrx, Inc.
2. The Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252 of the DGLA.
3. The effective date of the Merger shall be January 26, 2019
4. The name of the surviving corporation shall be Medtronic, Inc., a Minnesota corporation.
5. The Certificate of Incorporation for the surviving corporation shall remain unchanged.

The surviving foreign corporation agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of the surviving corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGLA, and, irrevocably appoints the Secretary of State of Delaware as its agent to accept service or process in any such action, suit or proceeding and the address to which a copy of such process shall be mailed to by the Secretary of State is 710 Medtronic Parkway, Minneapolis, MN 55432.
