WHEREAS, I, an undersigned individual, have invented certain invention(s) described in an application for Letters Patent (the “Application”) in:

2. I hereby covenant and agree to cooperate with NVIDIA to enable NVIDIA to enjoy to the fullest extent the right, title and interest to the Inventions herein conveyed in any and all countries and groups of countries. 4. I hereby warrant and represent that I have not entered into and will not enter into any assignment, license, contract, or understanding in conflict herewith.


