- (iii) The right, title and interest in the Patent Application and any patent granted in consequence thereof including the right to sue for damages and other remedies in respect of any infringement of said patent

TO HOLD the same unto GOODRICH absolutely

2. GOODRICH shall have the right to file applications for and/or be granted patents, utility models, registered designs, design patents, and any other intellectual property rights in its own name or in the name of the Inventor or in such other name or names as GOODRICH may desire and the Inventor acknowledges that if any such applications are filed or rights granted in the name of the Inventor the same shall be held in trust by the Inventor for GOODRICH and shall at the request of GOODRICH be transferred from the Inventor to GOODRICH for no further consideration.

3. The Inventor hereby covenants with GOODRICH if and when required by GOODRICH to sign execute and do all such further documents acts or things as may be necessary or desirable to enable GOODRICH to procure and enjoy the full and exclusive benefit of the Invention(s) and of all rights therein including patents, design patents, registered designs, utility models or other intellectual property rights
