RELEASE OF PATENT SECURITY INTEREST

This RELEASE OF PATENT SECURITY INTEREST ("**Release**") is made and effective as of December 31, 2020 and granted by Bank of America, N.A. , a U.S. National Banking Association, as collateral agent (the "**Collateral Agent**") for the secured parties under the Loan Agreement referred to below (the "**Secured Parties**"), in favor of Easton Diamond Sports, LLC, a Delaware limited liability company at 3500 Willow Lane, Thousand Oaks, CA 91361 (the "**Grantor**") and its successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Amended and Restated ABL Credit Agreement dated as of November 7, 2019 (the "**Loan Agreement**") among Peak Holdings, LP, as Holdings ("**Holdings**"), Bauer Hockey Ltd., as Lead Canadian Borrower, BCE Acquisition US, Inc., as Lead U.S. Borrower (the "**Lead US Borrower**"), certain additional subsidiaries of Holdings from time to time party thereto as Borrowers (including, without limitation, the Grantor), Bank of America, N.A., as Administrative Agent and Collateral Agent, and the lenders from time to time party thereto, the Grantor executed and delivered to the Collateral Agent (i) that certain Amended and Restated ABL U.S. Security Agreement by and among the Lead US Borrower and certain of its subsidiaries (including, without limitation, the Grantor) and the Collateral Agent dated as of November 27, 2017 (the "**Master Security Agreement**"), (ii) that certain Notice of Grant of Security Interest in Patents by and between the Grantor and the Collateral Agent dated as of February 27, 2017 (the "**Easton 2017 Patent Security Agreement**"), (iii) that certain Confirmation of Security Interest in Intellectual Property by and among Bauer Hockey Ltd., as grantor, and Collateral Agent dated as of February 27, 2017 (the "**Bauer 2017 Patent Security Agreement**"), (iv) that certain Notice of Grant of Security Interest in Patents by and between the Grantor and the Collateral Agent dated as of February 27, 2017 (the "**Easton 2017 Canadian Patent Security Agreement**") and (iv) that certain Notice of Grant in Security Interest in United States Patents by and between the Grantor and the Collateral Agent dated as of November 7, 2019 (the "**2019 Patent Security Agreement**" and, together with the Easton 2017 Patent Security Agreement, the Easton 2017 Canadian Patent Security Agreement and the Bauer 2017 Patent Security Agreement, the "**Patent Security Agreements**," and, together with the Master Security Agreement, the "**Security Agreements**");

WHEREAS, pursuant to the Security Agreements, the Grantor pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under, among other things, the Patent Collateral owned by the Grantor (as defined in each Patent Security Agreement), including but not limited to those described on Schedule A (collectively, the "**Patent Collateral**");

WHEREAS, the Easton 2017 Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 041873, Frame 0163;

WHEREAS, the Easton 2017 Patent Security Agreement was recorded with the Canadian Intellectual Property Office;

WHEREAS, the Easton 2017 Canadian Patent Security Agreement was recorded with the Canadian Intellectual Property Office;

WHEREAS, the Bauer 2017 Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 041482, Frame: 0353;

WHEREAS, the Bauer 2017 Patent Security Agreement was recorded with the Canadian Intellectual Property Office; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the termination, release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the Patent Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in the Patent Collateral, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the Patent Collateral, including without limitation:

(a) All common law rights associated with the Patent Collateral, together with the goodwill associated therewith and symbolized thereby, all other assets, rights and interest that uniquely reflect or embody such good will, and all renewals and extensions thereof;

(b) all rights and privileges of any kind whatsoever of such Grantor accruing under the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, damages and other proceeds now or hereafter due or payable with respect to the foregoing; and

(d) any and all claims and causes of action, with respect to the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages, and all other Proceeds (as such term is defined in the Master Security Agreement).

2. Authorization to Record. Collateral Agent authorizes and requests that the United States Patent and Trademark Office and the Canadian Intellectual Property Office and any applicable government officer records this Release.

3. Further Assurances. Collateral Agent agrees, at the Grantor's sole cost and expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

4. Limited Release. Notwithstanding anything to the contrary herein or otherwise, this Release is limited solely and only to the Patent Collateral and to no other Collateral (as defined in the Loan Agreement). The provisions of the Master Security Agreements shall, except as modified by this Release, continue in full force and effect.
