**ASSIGNMENT AGREEMENT**

THIS DEED OF ASSIGNMENT is dated *13 SEPTEMBER* 2018 and made

**BETWEEN**

TIPPIT, Justin, a US Citizen c/o Johnson Matthey, 4106 New West Drive, Pasadena, TX 77507, United States of America; and

ZHAO, Chun-tian, a British Citizen c/o Johnson Matthey, Belasis Hall Technology Park, Billingham, TS3 4ED, United Kingdom;

(each an "Inventor" and together the "Inventors"); and

JOHNSON MATTHEY PUBLIC LIMITED COMPANY, a company incorporated in England and Wales (registered number 00033774) having its registered office at 5th Floor 25 Farringdon Street, London, EC4A 4AB, United Kingdom ("JM").

**RECITALS**

(a) The Inventors have made an invention (the "Invention"), which is described in the patent specification entitled "Method for Reservoir Monitoring, Method of preparing a Reservoir, and Reservoir adapted for Monitoring" filed with Application No. 62/714181 made to the US Patent and Trademark Office Patent Office on 03 August 2018 and Application No 1813981.6 made to the UK Intellectual Property Office on 28 August 2018 (the "Applications").

(b) The Inventors have agreed to assign the their legal rights in and to the Invention and Application to JM on the terms set out in this Deed.

**WHEREAS** it is hereby agreed as follows:

**1. Assignment**

1.1 The Inventors hereby assigns to JM, all their legal right, title and interest in and to the Invention and Application, including:

- 1.1.1 the right to claim priority from such Application, and file for further patent applications in any territory of the world in respect of the Invention (the "Patent Applications");
- 1.1.2 the right to prosecute the Patent Applications and to obtain grant of patent or similar protection in or in respect of any country or territory in the world (each a "Patent");
- 1.1.3 the legal entitlement to any Patents granted pursuant to any Patent Applications comprised in the Patents or filed as aforesaid; and
- 1.1.4 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patents or any Patents granted on any of the Patent Applications in the Patents or filed as aforesaid, whether occurring before on or after the date of this Deed.

**2. Further Assurance**

2.1 At JM's expense the inventors shall promptly execute and deliver all such documents and do all such things as are necessary, required or requested by JM for the procurement of any Patent Applications, Patents or other form of protection anywhere in the world for the Invention, or as are otherwise required to give full effect to this Deed and the transaction intended to be effected pursuant to it, including:

2.1.1 the registration of JM as applicant for, or proprietor of, any Patents; and

2.1.2 assisting JM in obtaining, defending and enforcing any Patents, and assisting with any other proceedings which may be brought by or against JM against or by any third party relating to the rights assigned by this Deed.

### 3. No Further Compensation

Without prejudice to s.40 Patents Act 1977 or any similar provisions of law in any jurisdiction in favour of the inventors, the inventors acknowledges and agree that no further fees or compensation other than that already provided for pursuant to the inventor's employment in the JM group are due or may become due to the inventors under or in connection with this Deed.

### 4. Severance

If any provision or part-provision of this Deed is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this Deed.

### 5. Counterparts

This Deed may be executed in any number of counterparts and by the parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

### 6. Governing Law and Jurisdiction

6.1 This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

6.2 Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).


