
EMPLOYMENT CONTRACT

§ 10 Usufruct / Copyright in Work Results

- All work results of the employee are NORMA's property. They include the work results that
 the employee has achieved alone or together with employees when performing his work,
 also during the planning and development of EDP programmes, and, in addition, results
 that have been achieved not directly in connection with an ordered task, provided that they
 relate to the business operations or tasks of NORMA.
- 2. For all work results covered by copyright and achieved by the employment at NORMA, the employee grants NORMA exclusive and unlimited usufruct and exploitation right for all known kinds of usufruct and exploitation. They include, in particular, the right to reproduce, process, modify or translate the mentioned work results and to publish or exploit them in the original or modified form without the employee's explicit agreement. NORMA is further entitled, without special agreement in each case, to transfer this right entirely or partly to other persons or to grant other persons usufruct and exploitation rights.
- 3. All claims of the employee regarding the transfer of these rights to NORMA are satisfied based on the remuneration. This agreement shall be valid also after the end of the employment.


§ 11 Duty to Learn


If the requirements for the workplace of the employee change, in particular due to technical/organizational and/or competitive reasons, the employee agrees to acquire all

- 2. Employee invention law applies accordingly.


