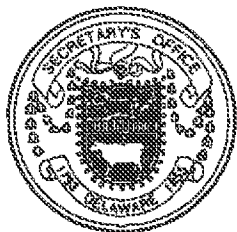



existing under the laws of the State of Delaware, and


WHEREAS this corporation desires to merge into itself the said
