Deed of Assignment United States of America

WHEREAS, OSRAM OLED GmbH (OSRAM), having its principal place of business at Wernerwerkstr. 2, 93049 Regensburg, Germany ("Assignor") (co-)owns certain patents, patent applications and/or abandoned patents, as set forth in Attachment 1 attached hereto and incorporated herein by reference ("Patents");

WHEREAS, Dolya Holdco 5 Limited, having its principal place of business at 10 Earlsfort Terrace, Dublin 2, D02 T380, Ireland ("Assignee"), desires to acquire Assignor's rights, title and interest in, to and under the Patents;

WHEREAS, Assignor and Assignee have entered into a certain patent purchase agreement dated June 25, 2020;

NOW, THEREFORE, the Parties hereto agree as follows:

(1) Definitions:

"Assignor Affiliate" means all existing and future entities which are directly or through one or more intermediaries, controlling, controlled by, or under common control with Assignor. For purpose of this definition "controlling" or "controlled" means ownership of securities representing fifty percent (50%) or more of the voting capital stock or other interest having voting rights with respect to the election of the board of directors or similar governing authority (including the authority to appoint or remove a general partner or manager), or any other power by contract or in any other form which entitles such named entity to the respective voting rights;

"Affiliate Owners" means the Assignor Affiliates owning one or more of the Patents, individually or jointly with others;

(2) Assignment:

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor, on behalf and for the commercial benefit of itself and the Affiliate Owners, does assign, transfer and convey onto Assignee (subject to certain encumbrances):

- a. all of OSRAM's and the Affiliate Owners' right, title and interest in and to the Patents;
- b. all of OSRAM's and the Affiliate Owners' right, title and interest in and to all reissues, re-examinations, continuations, continuations-in-part, divisionals and extensions of such Patents;
- c. all rights to apply (or continue prosecution) in any or all countries of the world for patents, certificates of invention, utility models, industrial design protections, design patent protections, or other governmental grants or issuances of any type related to any item in any of the foregoing categories a. and b.;
- d. all rights to revive prosecution of any abandoned Patent;

- e. all statutory rights, including the right to practice the Patents and to claim priority;
- f. all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights to sue or countersue or to pursue damages, injunctive relief and any other remedies of any kind for past, current, and future infringement under or on account of any of the Patents and/or any item in any of the foregoing categories a. through e.;
- g. all rights to recover and collect royalties and other payments due now or hereafter due or payable with respect thereto (excluding with respect to any existing licenses to the Patents, which are all retained by Assignor); and
- h. all privileges, including the benefit of all attorney-client privilege and attorney work product privilege.

(3) Assignor also hereby authorizes the United States Patent and Trademark Office to issue any and all patents or certificates of invention or equivalents which may be granted upon any of the foregoing in the name of Assignee.

(4) The terms and conditions of this Assignment shall inure to the benefit of and be binding upon Assignee, its successors, assigns and other legal representatives, and shall inure to the benefit of and be binding upon Assignor, its successor, assigns and other legal representatives.
