TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

This Termination and Release of Patent Security Agreement is made as of January 8, 2021, (“*Release*”) by WHITE OAK GLOBAL ADVISORS, LLC, a Delaware limited liability company (“*Administrative Agent*”) in favor of WELLSTAT OPHTHALMICS CORPORATION, a Delaware corporation (“*Grantor*”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.

WHEREAS, the Grantor and the Administrative Agent and the other parties thereto entered into that certain Loan Agreement, dated August 1, 2013.

WHEREAS, in connection with the Loan Agreement, the Grantor entered into a Patent Security Agreement, dated August 1, 2013, with the Administrative Agent, notice of which was recorded at the United States Patent and Trademark Office on August 15, 2013, at Reel 031030, Frames 0720 to 0734.

WHEREAS, under the Patent Security Agreement, the Grantor granted to the Administrative Agent a security interest and continuing lien on all of the Grantor’s right, title and interest in, to and under the Patent Collateral.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Patent Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness, and liabilities secured by Patent Collateral pursuant to the Patent Security Agreement and the Loan Agreement, the receipt and adequacy of which are hereby acknowledged and upon the terms set forth in this Release, the Administrative Agent agrees as follows:

Section 1. The Administrative Agent hereby terminates, releases and discharges its security interest in the Patent Collateral under the Patent Security Agreement, including without limitation (i) the Patents listed on **Schedule A** attached hereto, including all applications therefor; (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations thereof; (iii) all rights corresponding thereto throughout the world; (iv) all inventions and improvements described therein; (v) all rights to sue for past, present and future infringements thereof; (vi) all licenses, claims, damages, and proceeds of suit arising therefrom; and (vii) all proceeds, payments and rights to payments arising out of the sale, lease, license, assignment, or other disposition thereof. Any right, title or interest of the Administrative Agent in such Patent Collateral shall hereby cease and become void, and the Administrative Agent hereby reassigns any and all interest that it may have therein to the Grantor.

Section 2. The Administrative Agent hereby authorizes the filing of this Release in the United States Patent and Trademark Office by the Grantor or its designees.


Section 3. This Release may be executed and delivered by e-mail or other means of electronic transmission (including .pdf), and such transmission shall constitute an original for all purposes.
