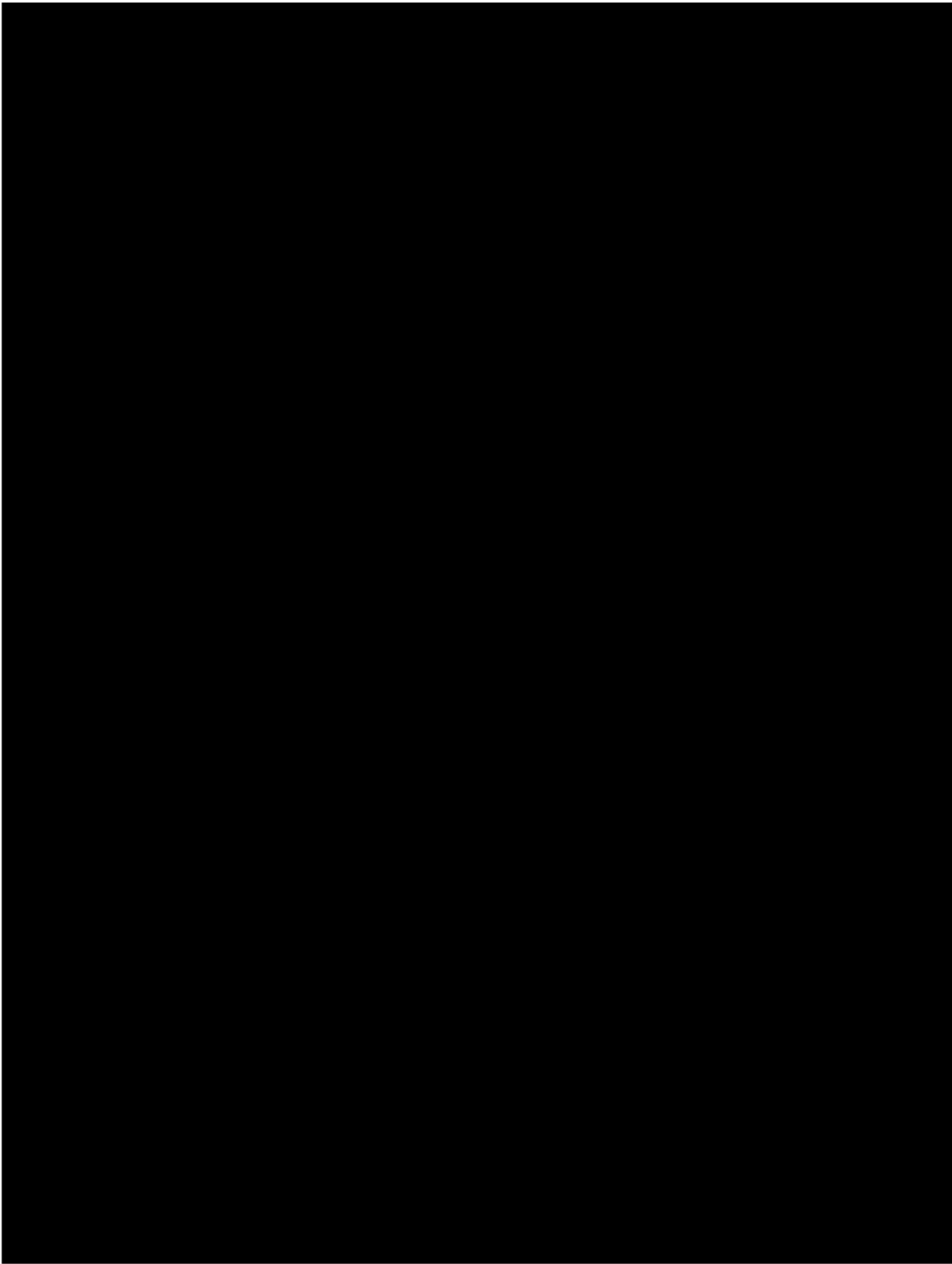
## **CONFIDENTIAL LICENSE AGREEMENT**

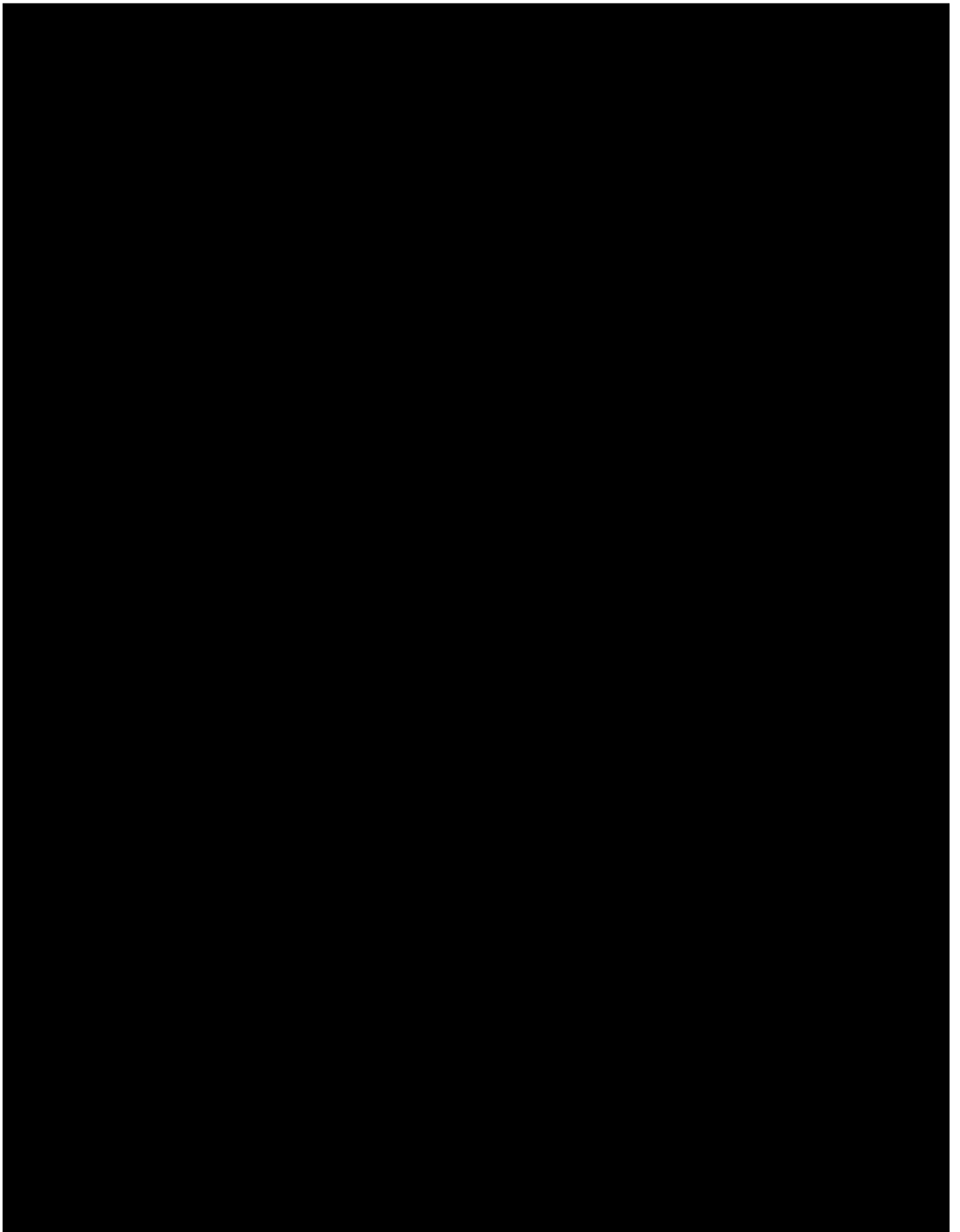

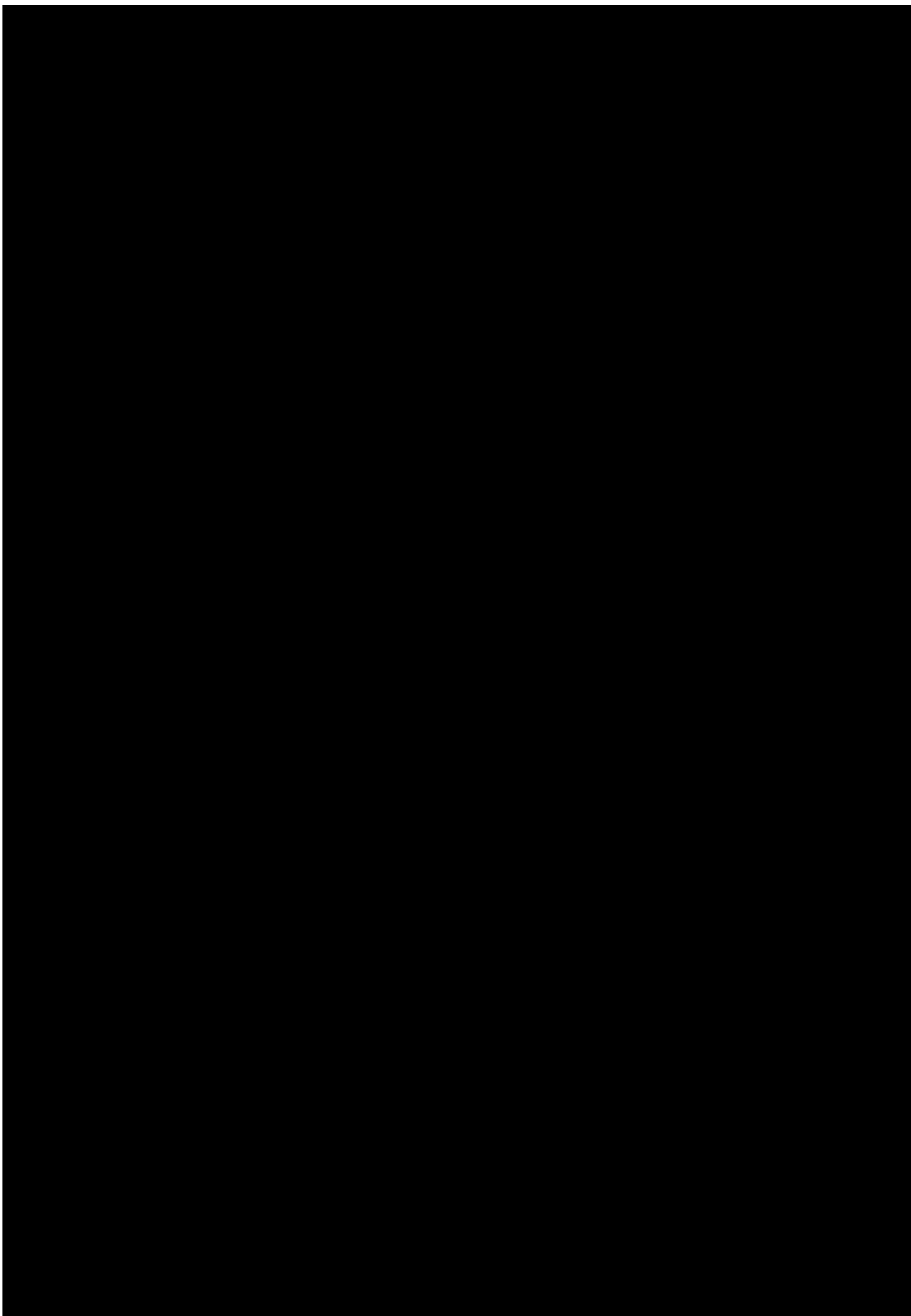





