Patent Assignment Agreement
U.S. Patent No. 6, 913,595

- 1. Parties; Patent.** This "Patent Assignment Agreement" ("**Agreement**") is between Emmanuel Mastorakis owner of record of U.S. Patent No. 6,913,595 (the "**Patent**") with offices at C/O Alliance Investments SAM, Le Panorama AB2 57 Rue Grimaldi, Monte-Carlo, Monaco 98000 and Omikron Group Limited company Registration No. 38596 with offices at C/O Harneys Corporate Services Limited, Craigmui Chambers Road, Town VG1110 Tortola, British Virgin Islands (collectively, "**Assignor**") and Numedico Technologies Pty Ltd. with offices at Unit 2, 21 Jenkins Avenue, Myrtle Bank, South Australia 5064 ("**Assignee**").
- 2. Effective Date.** This Agreement is effective December 20, 2020 ("**Effective Date**").
- 3. Nature of Agreement.** Assignor is the owner of the Patent. Pursuant to an Asset Sale Agreement dated 9 May 2020 ("APA") and a Deed of Amendment dated 15 October 2020 ("Deed"), Assignor agreed to sell certain business assets to Assignee, including the Patent. This Agreement confirms, and pursuant to the APA and Deed Assignor hereby assigns, transfers and conveys to Assignee, all right, title and interest in the Patent, together with (a) the right to sue or otherwise recover for any and all past, present and future infringements of the Patent; (b) all income, royalties, damages and other payments now and hereafter due and/or payable with respect to the Patent; (c) all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals; and (d) all other legal and beneficial ownership rights accruing thereunder or pertaining to the Patent.
- 4. General.** This Agreement shall be binding upon and inure to the benefit of the parties and their permitted successors and assigns. It implements the terms of the APA and the Deed and creates no new rights or obligations; in the event of any conflict between the APA/Deed and this Agreement, the terms of the APA/Deed shall govern.
