## Exhibit I - Registered Intellectual Property Assignment

### REGISTERED INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Registered Intellectual Property Assignment (this “**IP Assignment**”), dated and effective as of November 1, 2020 is made by **Medaptus, Inc.**, a corporation formed under the laws of Delaware (the “**Vendor**”), pursuant to that certain Asset Purchase Agreement dated the date hereof by and among the Vendor, **Medaptus Solutions Inc.** a corporation formed under the laws of Delaware and **Boston Millennia Partners II, L.P.**, a limited partnership established in the State of Delaware (the “**Purchase Agreement**”)

WHEREAS, under the terms of the Purchase Agreement, the Vendor has conveyed, transferred, and assigned to Buyer, among other assets, certain intellectual property of the Vendor, and has agreed to execute and deliver this IP Assignment, for recording with the United States Patent and Trademark Office;

NOW THEREFORE, The Vendor agrees as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Vendor hereby irrevocably conveys, transfers, and assigns to the Purchaser all of the Vendor's right, title, and interest in and to the following (the “**Assigned IP**”):

(a) the patents and patent applications set forth on Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof (the “**Patents**”);

(b) the trademark registrations and applications set forth on Schedule 2 hereto and all issuances, extensions, and renewals thereof (the “**Trademarks**”), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

(c) all rights of any kind whatsoever of the Vendor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. The Vendor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and

Trademark Office to record and register this IP Assignment upon request by the Purchaser at the Purchaser's sole cost and expense.

3. General. This IP Assignment is given pursuant to the terms of the Purchase Agreement. The Purchaser acknowledges that no Warrantor makes any representation or warranty with respect to the Assigned IP being assigned hereby except as specifically set forth in the Purchase Agreement. All capitalized terms used herein not otherwise defined shall have the same meanings as set forth in the Purchase Agreement. In the event of a conflict or inconsistency between the provisions of this IP Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement will prevail.
