## ASSIGNMENT OF PATENTS

**BETWEEN :**

**DATED** as of September 3, 2020 (the “**Effective Date**”)

**CONTEXT:**

- A.** The Assignor is the owner of all patents and patent applications that are set out in **Exhibit A** to this Assignment (the “**Patents**”).

- 1.1.1.5 the right to claim all benefits and priority rights with respect to the Patents and any of the foregoing under any applicable convention; and
- 1.1.1.6 the right to sue for all past and future infringements of, and to collect all past and future damages and royalties and other remedies available at law accruing from, any of the Patents and any of the foregoing,

with the intent that the foregoing are owned and enjoyed by Assignee absolutely and exclusively to the full end of the term or terms for same as they would have been by Assignors had this assignment, sale, set over, conveyance and transfer not been made.


