Whereas, University of Houston System, of 4800 Calhoun Road, Houston, Texas 77004 (hereinafter referred to as “ASSIGNEE”), is desirous of confirming its ownership of and acquiring the entire right, title and interest in and to the said invention, and to the said applications and any Letters Patent that may issue thereon;


