And ASSIGNOR further covenants and agrees that ASSIGNOR will without undue delay execute without further consideration all such papers as may be necessary to perfect the title to the ASSETS and LETTERS PATENT in the ASSIGNEE or its NOMINEES, and ASSIGNOR agrees to communicate to said ASSIGNEE or its NOMINEES all known facts respecting the ASSETS and LETTERS PATENT, to testify in any legal proceedings, to sign all lawful papers, and generally to do all things necessary to aid ASSIGNEE or its NOMINEES to obtain and enforce for their own benefit patent protection for said ASSETS in any and all countries, all at the expense of the ASSIGNEE or its NOMINEES;


