and that the Assignor will execute and deliver to the Assignee all additional papers which  
may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is authorized and requested to  
issue patents to the Assignee under the terms of this Assignment.

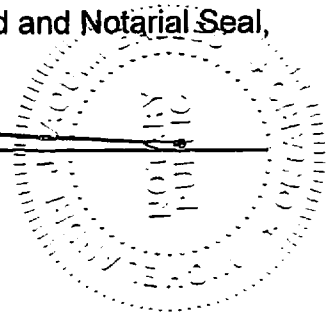

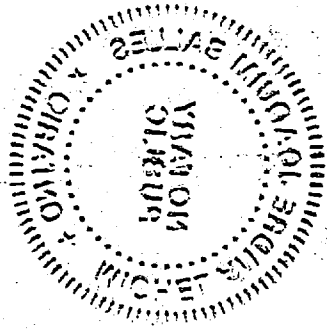
