ASSIGNMENT

WHEREAS, We, Stuart GIBSON, an Australian citizen, residing at 190 Deaves Road, Mandalong, New South Wales 2264, Australia; and Peter SCOTT, an Australian citizen, residing at 71 Burrell Valley Road, Laguna, New South Wales 2325, Australia, hereinafter referred to as "ASSIGNOR" (collectively if more than one inventor is listed above), have invented certain new and useful improvements in a SYSTEM AND METHOD OF RELEASABLY CONNECTING PIPE SECTIONS for which we have filed an International Application for Letters Patent designating the United States through the Patent Cooperation Treaty (PCT) which was filed on 27 August 2014 and assigned PCT Application No. PCT/AU2014/000850.





IN TESTIMONY WHEREOF, ASSIGNOR intending to be legally bound has hereunto affixed its signature.






