Together with Assignor's right, title and interest in and to the Patents, are the rights to police, monitor and enforce the Patents against any and all past infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this present Assignment.

Assignor agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described *nunc pro tunc* transfer of patent rights, or to secure issuance of same before the United States Patent and Trademark Office or any foreign Patent Office as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the Patent.

Assignor hereby grants to the designated attorneys in the United States and all pertinent foreign countries the Power to record this Assignment instrument before the United States Patent and Trademark Office, or such other appropriate foreign Patent/Intellectual Property Office, anywhere else in the world.
