"FIRST: The name of the Corporation is Indigo Ag, Inc. (the "Corporation")."

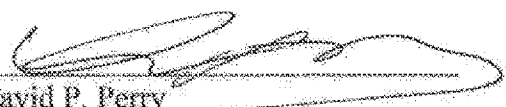
2. That such amendment was duly adopted in accordance with Section 242 of the General Corporation Law.
