## RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), dated as of January 29, 2021 (the “Effective Date”), is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, in its capacity as notes collateral agent pursuant to the Indenture (in such capacity, the “Notes Collateral Agent”), in favor of Refinitiv US Organization LLC (formerly known as Thomson Reuters (GRC) Inc.), a Delaware limited liability company (the “Grantor”) and its Affiliates.

WHEREAS, pursuant to that certain Security Agreement, dated as of October 1, 2018, by and among the Notes Collateral Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Notes Security Agreement”), the Grantor granted to the Notes Collateral Agent, in its capacity as Notes Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in, to and under all of its right, title, and interest in, to and under the Patent registrations and applications of the Grantor, including those listed on Schedule A attached hereto;

WHEREAS, pursuant to the Notes Security Agreement, the Grantor executed and delivered, in favor of the Notes Collateral Agent, in its capacity as Notes Collateral Agent, for the benefit of the Secured Parties, a Patent Security Agreement (Short Form), dated as of October 1, 2018 (the “Patent Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2018 at Reel/Frame 047187/0316;

WHEREAS, a Partial Release of Patent Security Agreement, dated as of February 13, 2019, under which the Notes Collateral Agent executed and delivered the release of the Security Interest in two Patents (Registration Nos. 7,433,842 and 7,734,518), was recorded with the United States Patent and Trademark Office on March 1, 2019 at Reel/Frame 048479/0489;

WHEREAS, the Notes Security Agreement and Patent Security Agreement have terminated and all liens thereunder were released automatically in accordance with Section 6.11 of the Notes Security Agreement;

WHEREAS, in accordance with Section 6.11(d) of the Notes Security Agreement, the Notes Collateral Agent shall execute and deliver to any Grantor all documents that such Grantor shall reasonably request to evidence such termination or release;

NOW, THEREFORE, in accordance with Section 6.11 of the Notes Security Agreement, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Notes Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Notes Security Agreement or the Patent Security Agreement, as applicable.

2. Release. The Notes Collateral Agent, without representation or warranty of any kind, hereby acknowledges the automatic release, discharge, termination and cancellation of, and hereby releases, discharges, terminates and cancels all of its Security Interest in, to and under all issued and applied for Patents of the Grantor, including, without limitation, those listed on Schedule A attached hereto, arising under the Notes Security Agreement and the Patent Security Agreement, and all Proceeds of the foregoing



(the "Patent Collateral"). If and to the extent that the Notes Collateral Agent has acquired any right, title or interest in, to and under the Patent Collateral, the Notes Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Notes Collateral Agent, without representation or warranty of any kind, acknowledges the automatic termination and cancellation of, and hereby terminates and cancels the Patent Security Agreement.


4. Further Assurances. The Notes Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Notes Collateral Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
