## CONFIRMATION OF PATENT ASSIGNMENT

This Confirmation of Patent Assignment is entered into by and between **FORMA THERAPEUTICS, INC.**, a Delaware corporation having a place of business at 500 Arsenal St., Suite 100, Watertown, Massachusetts 02472 ("FTI"), and **FORMA TM2, INC.**, a Delaware corporation having a place of business at 500 Arsenal St., Suite 100, Watertown, Massachusetts 02472 ("FTM2").

**WHEREAS**, FTI has an interest in the patent applications and patents listed on Schedule A, attached hereto and a part of this agreement (collectively, the "Patents"), by virtue of assignment from at least one inventor;

**WHEREAS**, FTI, FTM2, and Forma Therapeutics Holdings, LLC, a Delaware limited liability company ("FTH"), entered into a Contribution Agreement effective December 8, 2016 (the "Contribution Agreement");

**WHEREAS**, pursuant to Section 2.1.1 of the Contribution Agreement, FTI, FTM2, and FTH agreed that the whole right, title, and interest in and to the Patents would be sold, conveyed, transferred, assigned, and delivered by FTI to FTM2; and

**WHEREAS**, FTI, FTM2, and FTH wish to confirm that FTI has sold, conveyed, transferred, assigned, and delivered and/or does hereby sell, convey, transfer, assign, and deliver to FTM2, FTI's whole right, title, and interest in and to the Patents.

**NOW THEREFORE**, pursuant to such Contribution Agreement and in consideration of the terms set forth therein, FTI hereby confirms that it has sold, conveyed, transferred, assigned, and delivered and does hereby sell, convey, transfer, assign, and deliver to FTM2, FTI's whole right, title, and interest, free from all encumbrances, in and throughout the United States of America, its territories, and all foreign countries, in and to the Patents, including any right of priority thereto. This Confirmation of Patent Assignment applies i) to the Patents, ii) to any patent application that is based in whole or in part on the Patents, including any divisional, continuing, substitute, renewal, reissue, reexamination, and other patent application(s), including any patent application(s) that claim foreign priority to or domestic benefit of the Patents, and iii) any patent application claiming foreign priority to or domestic benefit of the Patents and which covers solely Subsidiary Initial Know-How that was discovered, developed, generated, invented, conceived, and/or reduced to practice and solely related to the Initial Subsidiary Target of mtlDH1 as of the December 8, 2016 effective date of the Contribution Agreement by and among FTI, FTM2, and FTH. Also, this Confirmation of Patent Assignment pertains to any and all other rights, privileges, and advantages, including any and all rights to damages, profits, or recoveries of any nature for past infringement of the Patents, arising under or pursuant to any and all international agreements, treaties, or laws relating to the protection of industrial property, including all rights of priority under the International Convention for the Protection of Industrial Property, and in and to any such patent(s) as may issue thereon including any and all original and reissued patents which have been or shall be issued in the United States and foreign countries; said patent applications and patent(s) to be held and enjoyed by FTM2 for its own use and for each of its successors, assigns, and legal representatives, to the full end of the term for which said patent(s) may be granted as fully and entirely as the same would have been held by FTI had FTI, FTM2, and FTH not entered into the Contribution Agreement.

**AND** for the same consideration, FTI hereby covenants and agrees to and with FTM2, their successors, legal representatives and assigns that FTI will, at the cost and expense of FTI, sign all papers

and documents, take all lawful oaths, and do all acts necessary or required to be done for the recordation of this Confirmation of Patent Assignment to FTM2.


**AND** FTI hereby requests the Director of the United States Patent and Trademark Office to issue any and all patents of the United States arising from such United States patents and patent applications included in the Patents to FTM2, its respective successors, legal representatives, and assigns.
