Whereas, Assignor has agreed to convey, transfer and assign to Assignee the rights in the U.S. National Phase patent application based on U.S. Provisional Application Number 62/068,074, subsequently filed as PCT Application PCT/US2015/055205 and from which a U.S. National Phase Patent Application was filed and assigned U.S. Serial No. 15/521,099 and said U.S. National Phase Patent Application has issued as U.S. Patent No. 10,590,012 on March 17, 2020 (PATENT), and has agreed to execute and deliver this Patent Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the PATENT to Assignee, or any assignee or successor thereto.
3. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.
