RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of January 14, 2021, by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Administrative Agent under (and as defined in) the Credit Agreement referred to below (the "Agent") for the benefit of **COOLEY GROUP HOLDINGS, INC.**, a Delaware corporation, **COOLEY, INCORPORATED**, a Rhode Island corporation, and **RISC, LLC**, a Delaware limited liability company (the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement (as defined below) or the Security Agreement (as defined below) as applicable.

W I T N E S S E T H:

WHEREAS, the Grantors and the Agent are parties to that certain (i) Revolving Credit, Term Loan and Security Agreement, dated as of September 30, 2008 (as amended, amended and restated, modified, or supplemented and in effect from time to time, the "Credit Agreement"; and (ii) Intellectual Property Security Agreement, dated as of September 30, 2008 (as amended, amended and restated, modified, or supplemented and in effect from time to time, the "Security Agreement"), pursuant to which the Grantors have granted to the Agent for the benefit of the Lenders a lien on and security interest in all of the right, title and interest of the Grantors in, to and under the Intellectual Property (as defined in the Security Agreement), including the trademarks set forth on Schedule I hereto, patents set forth on Schedule II hereto, and copyrights set forth on Schedule III hereto; and

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on October 1, 2008 at Reel 3862 and Frame 0872 for trademarks, and on October 1, 2008 at Reel 021617 and Frame 0193 for patents, and with the United States Copyright Office on October 9, 2008 at Volume 3571 and Document 497 for copyrights; and

WHEREAS, the Grantors have requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Intellectual Property, including, without limitation, the trademarks set forth on Schedule I hereto, the patents set forth on Schedule II hereto, and the copyrights set forth on Schedule III hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Credit Agreement or Security Agreement to the Intellectual Property, including, without limitation, the trademarks (including the trademark registrations and trademark applications) set forth on Schedule I hereto, the goodwill of the business symbolized by the trademarks and the applications and registrations thereof, the patents (including the patent registrations and patent applications) set forth on Schedule II hereto, and the copyrights (including the copyright registrations and copyright applications) set forth on Schedule

III hereto, and all proceeds thereof, and any right, title or interest of the Agent in such Intellectual Property shall hereby terminate, cease and become void. The Agent hereby assigns, transfers and conveys any and all right, title or interest of the Agent in the Intellectual Property to the Grantors.

2. The Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the Security Agreement.

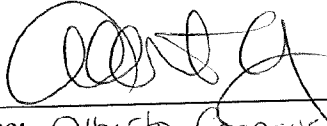
