4. The Employees will at the request of the Employer do all such further things and execute all such further documents as the Employer may from time to time require for the purpose of confirming or recording the Employer's title to the Invention in any part of the world.
5. This Deed shall be governed by and construed according to the laws of the State of Victoria, Australia.





