

In consideration of the employment, or continued employment, of the Employee by the Company, it is agreed as follows:

- 1) All ideas, inventions, discoveries, trademarks, writings, proprietary information, knowhow, works for hire, processes and other developments or improvements or works for hire (referred to herein as "inventions") conceived by the Employee, whether relating to patentable or copyrightable subject matter or not, during the period(s) of employment by the Company, whether made or conceived during or out of the usual hours of work, which arise out of or are related to (a) any work to which the Employee shall be assigned by the Company, (b) the business, research or development work of the division of the Company to which the Employee is assigned or (c) the business, research or development work of any other division of the Company, shall be the Company's property .The Employee acknowledges an obligation to assign all such inventions to the Company and agrees to disclose all such inventions promptly, completely and in writing to proper representatives or attorneys of the Company. The foregoing shall not apply to an invention for which no equipment, supplies, facility or trade secret information of the Company was used and which was developed entirely on Employee's own time, and (1) which does not relate (a) to the business of the Company, or (b) to the company's actual or demonstrably anticipated research or development, or (2) which does not result from any work performed by the Employee for the Company.
