- I, Bethany R. Lahmann, do hereby declare as follows:
- 1. I, a registered patent attorney, filed the above-identified application, on February 12, 2020 on behalf of Applicant Clearstream Technologies Limited.
- 2. The inventors of the subject matter claimed in the above-identified application are James Kehoe, Dónal McDonagh, and John O'Shea. Assignment documents from Dónal McDonagh and John O'Shea to Clearstream Technologies Limited are submitted separately.

c. Sub-Paragraph (c) states:

"You hereby appoint the Company to be your attorney in your name and on your behalf to execute and do any such instruments or things and generally to use your name for the purpose of giving to the Company or its nominees the full benefit of these provisions."

7. On **August 8, 2020** we received an executed assignment assigning this application from the company to whom the Contract of Employment was for, Embo Medical Ltd. *(assignee)*, to the Application Clearstream Technologies *(assignor)*. This assignment document is being submitted separately.
