RELEASE OF GRANT OF SECURITY INTERESTS IN PATENTS

THIS RELEASE OF GRANT OF SECURITY INTERESTS IN PATENTS (this “**Release**”) is made as of February 3, 2021 (the “**Effective Date**”) by FIRST EAGLE PRIVATE CREDIT, LLC, as successor to Newstar Financial, Inc., as administrative agent (the “**Administrative Agent**”), in favor of ZBT ACQUISITION CORP., a Delaware limited liability company (“**ZBT**”); ZETA GLOBAL CORP., a Delaware limited liability company (“**Zeta Global**”); 935 KOP ASSOCIATES, LLC, a Delaware limited liability company (“**935 KOP**”); and each of the other subsidiaries which became grantors prior to the date hereof (each, a “**Grantor**”, and collectively the “**Grantors**”) to each Grant of Security Interest in Patents described below (each, a “**Patent Security Interest Grant**” and, collectively, the “**Patent Security Interest Grants**”). All terms not herein defined, have the meanings set forth in the Patent Security Interest Grants referenced below.

WHEREAS, ZBT, Zeta Global, 935 KOP, Zeta Global Holdings Corp., a Delaware corporation, as borrower (the “**Borrower**”), the other Obligors from time to time party thereto, the lenders from time to time party thereto (the “**Lenders**”) and the Administrative Agent are parties to that certain Credit Agreement dated as of July 10, 2015 (as amended, restated, amended and restated, modified, extended, replaced, or supplemented from time to time, the “**Credit Agreement**”) pursuant to which the Lenders agreed to make certain loans to the Borrower;

WHEREAS, pursuant to the Credit Agreement, ZBT, Zeta Global, 935 KOP, the other Obligors from time to time party thereto and the Administrative Agent entered into that certain Guaranty and Security Agreement, dated as of July 10, 2015 (as amended, restated, amended and restated, modified, extended, replaced, or supplemented from time to time, the “**Guaranty and Security Agreement**”) for benefit of the secured parties referenced therein (the “**Secured Parties**”);

WHEREAS, pursuant to the Guaranty and Security Agreement, each Grantor was required to execute and deliver a Patent Security Interest Grant to the Administrative Agent for purposes of filing with the United States Patent and Trademark Office (“**USPTO**”);

WHEREAS, pursuant to the Credit Agreement and each Patent Security Interest Grant, each Grantor granted and conveyed to the Administrative Agent on behalf of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligor in and to the Patents as defined in the applicable Patent Security Interest Grant including, without limitation, those listed on Schedule A hereto (the “**Released Patents**”);

WHEREAS, a Patent Security Interest Grant, dated November 2, 2015, executed by 935 KOP was recorded in the patent assignment office of the USPTO on November 3, 2015 at reel/frame 036949/0748; and

WHEREAS, a Patent Security Interest Grant, dated July 14, 2017, executed by ZBT was recorded in the patent assignment office of the USPTO on July 17, 2017 at reel/frame 043024/0607; and

WHEREAS, a Patent Security Interest Grant, dated December 2, 2020, was executed by Zeta Global was recorded in the patent assignment office of the USPTO on December 3, 2020 at reel/frame 054585/0770.


WHEREAS, all indebtedness of the Obligors for credit extended under the Credit Agreement has been fully paid and discharged and the Administrative Agent wishes to release its security interest in the Released Patents and terminate the Patent Security Interest Grants.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates each Patent Security Interest Grant and terminates, releases and discharges any security interest in and lien upon the Released Patents and conveys to each Grantor, without representation, warranty or recourse of any kind, any and all right, title or interest in, or to, the Released Patents that the Administrative Agent may hold. The Administrative Agent agrees, at each Grantor's expense, to take all further reasonable actions, and provide to each Grantor and its successors, assigns and legal representatives all such reasonable cooperation and assistance as each Grantor and its successors, assigns and legal representatives may reasonably request in order to effectuate of record this Release.
