To whom it may concern:

In 2013 the State of Oregon Legislature passed Senate Bill 270 (Or Laws 2013, ch 768). By operation of law, on July 1, 2014 Oregon State University is no longer a part of the Oregon University System (OUS). Oregon State University is a separate governmental entity of the State of Oregon.

As of July 1, 2014, by operation of law, intellectual property owned by the State of Oregon, the Oregon University System, the State Board of Higher Education, or a comparable State of Oregon entity, through or on behalf of Oregon State University, is now owned by Oregon State University, a governmental entity of the State of Oregon, in its own capacity.
