PATENT ASSIGNMENT

This PATENT ASSIGNMENT (hereinafter “Assignment Agreement”), is effective as of October 28, 2020 (the “Effective Date”), by and between **ATRIUS LIMITED**, a limited liability company incorporated and registered in Ireland whose registered office is at Suite 3, One Earlsfort Centre, Lower Hatch Street, Dublin 2 (“**ATRIUS**”), and **CONVEYOR CARDIOVASCULAR LIMITED** a limited liability company incorporated and registered in Ireland whose registered office is at Suite 3, One Earlsfort Centre, Lower Hatch Street, Dublin 2, (“**CCL**”). ATRIUS and CCL are referred to herein individually as “Party” and, collectively, the “Parties.”

RECITALS

ATRIUS owns the patents and patent applications listed at Appendix A attached hereto (the “Patents”);

ATRIUS wishes to transfer to CCL, and CCL wishes to receive, all right, title and interest in and to the Patents.

NOW, THEREFORE, for and in consideration of the consideration set forth herein and in the Termination Agreements, the receipt and sufficiency of which are hereby acknowledged:

1. ATRIUS hereby irrevocably transfers, conveys and assigns to CCL, and CCL shall acquire from ATRIUS all right, title and interest in and to all (a) Patents, including, without limitation, any divisions, renewals, continuations in whole or in part, substitutions, conversions, reissues, prolongations or extensions thereof, causes of action and rights to damages, payments, royalties and income for past, present or future infringements or misappropriations with respect thereto, in all countries relating to the Patents, and (b) all unpatented technical information that is not in the public domain, and all information and techniques (not publicly known), in each case that are owned by ATRIUS and necessary or useful for the practice of the Patents (collectively, the “Know How”).

2. Upon CCL’s request, with reasonable notice given, and without additional consideration, ATRIUS shall execute any further papers and documents and do such other acts as may be necessary and proper to vest full title in and to the Patents and Know How in CCL.

3. ATRIUS irrevocably constitutes and appoints CCL, with full power of substitution, to be its true and lawful attorney, and in its name, place or stead, to execute, acknowledge, swear to and file, all instruments, conveyances, certificates, agreements and other documents, and to take any action which shall be necessary, appropriate or desirable to effectuate the transfer, or prosecution of the Patents in accordance with the terms of this Agreement; provided, however, that such power shall be exercised by CCL only in the event that ATRIUS fails to take the necessary actions required hereunder to affect or record such transfer, or prosecution of the Patents following CCL’s reasonable request, and being given a reasonable opportunity to do so. This power of attorney shall be deemed to be coupled with an interest and shall be irrevocable.



