

This declaration is submitted to **correct the name of Receiving Party (Assignee) in the Cover Sheet** recorded under **Reel 043189 and Frame 0365 on August 3, 2017** with respect to **U.S. Patent No. D791043**.



The original assignment (dated September 1, 2016) filed under **Reel 043189 and Frame 0365 on August 3, 2017** reflected that the patent application of U.S. Patent No. D791043 was assigned to "THE WHEEL GROUP"; however, the **Receiving Party (Assignee)** was mistakenly written as "CIA WHEEL GROUP, DBA THE WHEEL GROUP" in the **Cover Sheet**. As WGH is the true and correct owner of "THE WHEEL GROUP" name since at least 2015, the Receiving Party's name that was mistakenly stated in the **Cover Sheet** filed under **Reel 043189 and Frame 0365** must be corrected to read the "Wheel Group Holdings, LLC dba The Wheel Group" for the U.S. Patent No. D791043.
