ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, we, Christian Pruckner, Bernhard Silberer and Johann Eibl hereby sell, assign, and transfer to W&H Dentalwerk Bürmoos GmbH, the full and exclusive right, title, and interest in and to said invention, patent application, and patent rights throughout the world, including foreign patent priority rights, the right to file and prosecute International Applications under the Patent Cooperation Treaty, and the right to file and prosecute applications under the European Patent Convention; said invention, patent application, and letters patent in this or any foreign country, and all corresponding non-provisional applications, divisions, continuations, continuations-in-part, reissues, and extensions thereof, to be held and enjoyed by W&H Dentalwerk Bürmoos GmbH, for its own use and benefit, and for its successors and assigns to the full end of the term for which letters patent may be granted by the United States or any foreign country, as fully and entirely as the same would have been held by us had this assignment and sale not been made, and covenant that we have full right so to do, and agree that we will communicate to W&H Dentalwerk Bürmoos GmbH, or its successors and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and do everything possible to aid W&H Dentalwerk Bürmoos GmbH, its successors, and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.

We confirm that, at the time the invention was made, we were under an obligation to assign the invention to W&H Dentalwerk Bürmoos GmbH.




