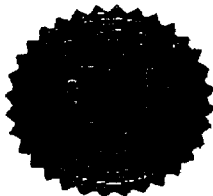

FIRST: That the names of each of the constituent corporations of the merger are: International Securities Exchange LLC, a New York limited liability company (the "Merging Corporation"), and International Securities Exchange, Inc., a Delaware corporation ("ISE").
