## TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS dated as of March 1, 2021 (this "**Release**"), is made by CRG SERVICING LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, "**Administrative Agent**"), in favor of Preventice Solutions, Inc., a Delaware corporation ("**Company**").

WHEREAS, pursuant to that certain Security Agreement, dated as of February 5, 2019, (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Company, other grantors from time to time party thereto, and the Administrative Agent, the Company pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Company's right, title and interest in, to and under all of its personal property, including without limitation the patents and patent applications listed on Schedule A hereto;

**WHEREAS**, pursuant to the Security Agreement, the Company executed and delivered to Administrative Agent, for the benefit of the Secured Parties, a Patent Security Agreement, dated February 5, 2019 (the "**Patent Security Agreement**");

**WHEREAS**, the Patent Security Agreement was recorded at the United States Patent and Trademark Office ("**USPTO**") on February 5, 2019, at Reel 048244, Frame 0272.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the Secured Parties, and Company agree as follows:

**SECTION 1**. <u>Defined Terms</u>. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2**. <u>Termination and Release</u>. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of the Company's right, title, and interest in, to and under all of the patents and patent applications, whether now owned or at any time hereafter acquired, of the Company that are issued by or filed with the USPTO, including the patents and patent applications listed on **Schedule A** hereto; and

(b) authorizes the recordation of this Release with the USPTO at Company's expense.

**SECTION 3.** <u>Choice of Law</u>. This Release and obligations of the parties hereunder shall be governed by, and construed in accordance with, the law of the State of New York, without regard to principles of conflicts of laws that would result in the application of the laws of any other jurisdiction; provided that Section 5-1401 of the New York General Obligations Law shall apply.
