# INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT AGREEMENT

THIS AGREEMENT is entered into on the 1<sup>st</sup> of January 2021 (hereinafter referred to as the "Agreement") by and between

Cargotec Patenter AB (business identity code 556113-9154), a Swedish company having its principal place of business in Stockholm, Sweden (hereinafter referred to as "the Assignor");

and

Hiab AB (business identity code 556981-2828), a Swedish company having its principal place of business in Stockholm, Sweden (hereinafter referred to as "the Assignee")

(collectively, the "Parties")

WHEREAS, the Assignor is the present proprietor of trademarks, tradenames and domain names related to the business area "Hiab", as they are used, kept and upheld by Cargotec Corporation and its affiliated companies worldwide, as specified in Annex I of this Agreement (hereinafter referred to as the "Trademarks");

WHEREAS, the Assignor further is the present proprietor or applicant of certain patents related to the business area "Hiab", as specified in Annex II of this Agreement (hereinafter referred to as the "Patents");


WHEREAS, the Assignor wishes to assign and transfer all its rights relating to the Trademarks and Patents, including all other intellectual property rights of which the Assignor is a proprietor and which relate to the business area "Hiab" not specifically listed in Annex I and Annex II (hereinafter referred to as the "other Hiab IPRs") as well as all license agreements with Cargotec Corporation and its affiliated companies worldwide relating to the business area "Hiab", to the Assignee for the consideration and upon the terms and subject to the conditions set forth in this Agreement.


NOW, THEREFORE, the Parties hereby agree as follows:

1. The Assignor hereby assigns and transfers to the Assignee and the Assignee accepts and receives the entire right, title and interest in and to the Trademarks, together with the goodwill of the business associated with them, Patents and, as the case may be, any other Hiab IPRs.
2. The validity, performance and construction of this Agreement shall be governed by and interpreted in accordance with the laws of Finland. All disputes arising out of or in connection with this Agreement shall be finally settled by arbitration in accordance with Arbitration Rules of the Finnish Central Chamber of Commerce by one arbitrator appointed in accordance with the said Rules. The arbitration shall take place in Helsinki, Finland.


IN WITNESS WHEREOF the parties hereto have executed this Agreement in two copies of which each party has taken one copy.



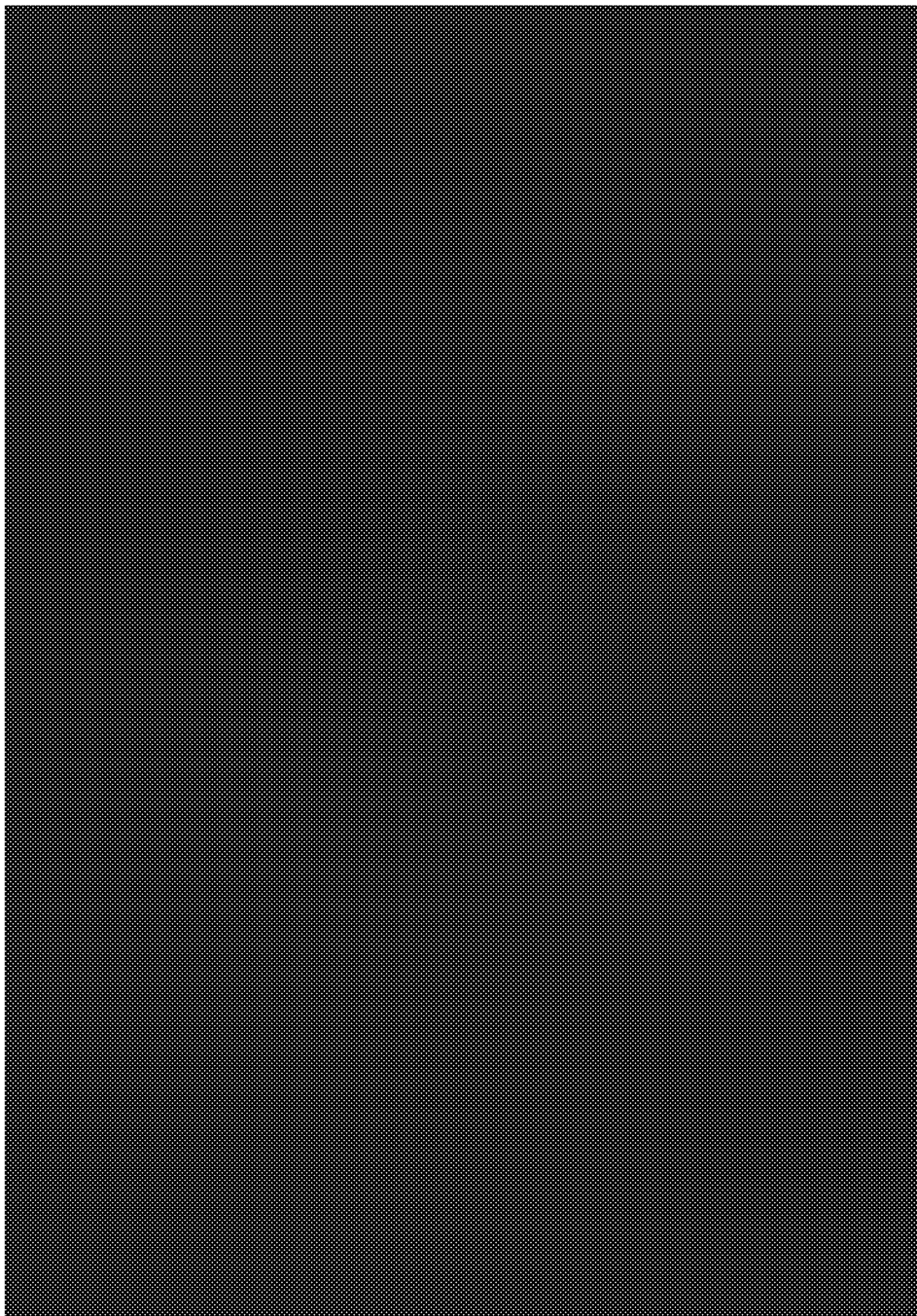

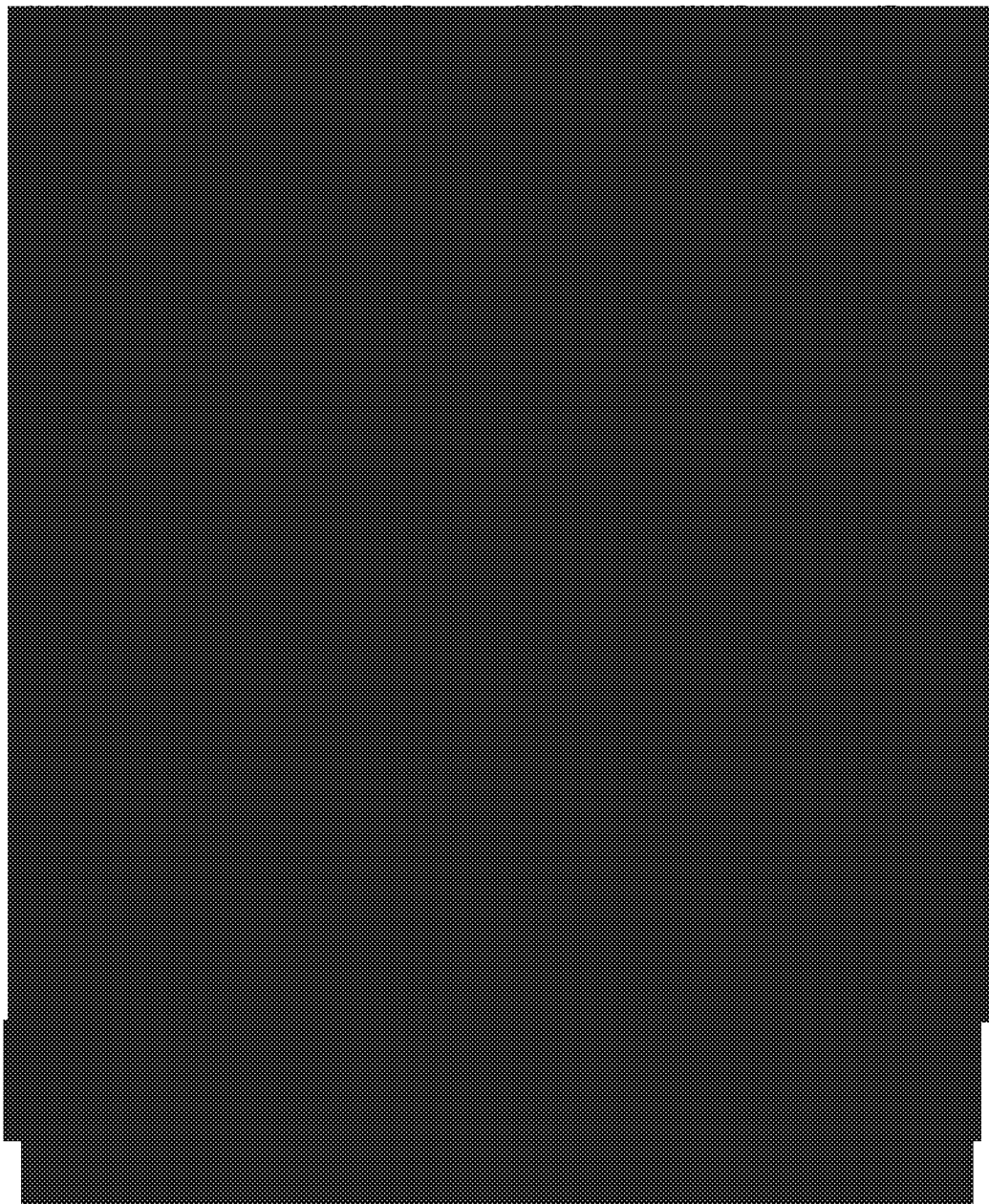
