INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("Assignment"), effective as of June 30, 2019, is by and between Volta Industries, Inc. ("Assignor"), a Delaware corporation, located at 155 De Haro Street, San Francisco, CA 94103, and Volta Charging, LLC, a Delaware limited liability company, located at 155 De Haro Street, San Francisco, CA 94103 ("Assignee").

WHEREAS, Assignor is the sole member of Assignee, and Assignee presently exercises rights in all intellectual property of Assignor; and

WHEREAS Assignor desires to convey, transfer, and assign to Assignee all Assignor's rights, title and interest in and to all intellectual property of Assignor, including all obligations relating thereto; and

WHEREAS, Assignee desires to receive from Assignor all Assignor's rights, title and interest into intellectual property interests of Assignee, including all obligations relating thereto;

NOW, THEREFORE, for good, valuable and sufficient consideration that Assignor and Assignee each acknowledge receiving, Assignor and Assignee agree as follows:

I. Assignment. Assignor hereby conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all Assignor's right, title, and interest in and to the following:

(a) Registered or applications to register copyrights, trademarks (other than any intent-to-use trademark applications) and patents, including any issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof ("**Registered Intellectual Property**"), including but not limited to that Registered Intellectual Property shown as Exhibit A;

(b) all rights in and to trade secrets, inventions, ideas, works, marks, brands, designs, indicia of source, data, databases, software, rights of privacy or publicity, unregistered copyrights, and any other form of proprietary rights ("**Unregistered Intellectual Property**", with the Registered Intellectual Property, the "**Assigned Intellectual Property**");

(c) all goodwill in any Assigned Intellectual Property;

(d) all rights of any kind whatsoever of Assignor accruing under any of the Assigned Intellectual Property provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(e) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the Assigned Intellectual Property; and

(f) any and all claims and causes of action with respect to any of the Assigned Intellectual Property, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, dilution, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Intellectual Property to Assignee, or any assignee or successor thereto.

3. Successors and Assigns. This Intellectual Property Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

4. Governing Law. This Intellectual Property Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Intellectual Property Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of California, without giving effect to any choice or conflict of law provision or rule, whether of the State of California or any other jurisdiction.
