CONFIRMATORY ASSIGNMENT

WHEREAS, NeuroStructures, LLC, a California limited liability company ("LLC"), pursuant to a December 31, 2013 Written Consent of The Sole Member of NeuroStructures, LLC ("Written Consent"), on December 31, 2013, filed with the Secretary of State in the State of California a Certificate of Dissolution and a Certificate of Cancellation to wind up and dissolve LLC, such Written Consent authorizing LLC to distribute assets of LLC to the sole Member of LLC;


WHEREAS, the sole Member of LLC on December 31, 2013 was NeuroStructures, Inc., a California corporation established pursuant to Articles of Incorporation filed with the Secretary of State in the State of California on December 18, 2013 ("INC") for the purpose of continuing certain aspects of the business of LLC, INC having purchased all outstanding Class A and Class B ownership interests in LLC such that INC owned all interests in LLC prior to dissolution; and

WHEREAS, pursuant to a December 10, 2014 Agreement Regarding Assignments, INC (a) consented to the conveyance, transfer and assignment from Blackstone Medical, Inc., d/b/a Orthofix Spinal Implants, to Howmedica Osteonics Corp. of an Exclusive License Agreement and a Distribution Agreement relating to the Tempus product ("the Tempus agreements"), both dated January 11, 2013 and amended August 15, 2014, and (b) assigned to Howmedica Osteonics Corp. the right, title and interest in and to the "Intellectual Property Rights" subsisting in (i) the Tempus trademark, together with the goodwill established through the past use of and symbolized by the Tempus trademark, and including U.S. Trademark Registration No. 4,353,896, (ii) the "Licensed Patents," (iii) the "Licensed Non-Patent IP" and (iv) "Further Developments," as each quoted term is defined and set forth in the Exclusive License Agreement and in Exhibit A thereof, Exhibit A being reproduced (and updated for convenience) on Schedule A hereto, such assignment including all copyrights subsisting in all published or unpublished materials relating to the manufacture, marketing, sale and use of the Tempus plate distributed by Orthofix, including all design files, engineering drawings, advertising, marketing and promotional materials, clinical materials, surgical protocols and templates, and photographs; and as such, the foregoing assignment includes the assignment of all of the right, title and interest in and to all works of authorship ("Works") that are based upon, derived from or incorporate the copyrights included in the Intellectual Property Rights, and includes the right to use the Works for any purpose whatsoever, including the rights to publish, display, distribute, reproduce, modify, derive from, revise, license, sell, use and commercialize the Works throughout the world, in any form or medium, LLC expressly retaining no rights whatsoever to the Works and forfeiting any reversionary rights, recapture rights or any other rights associated with the Works, and also including the right to sue for and collect for Howmedica Osteonics Corp.'s sole benefit all past damages for any infringement, violation or misappropriation of any of the assigned rights (hereinafter, collectively "the Transferred IP Assets").

In connection with winding up its affairs in December 2013, LLC transferred all of its right, title and interest in and to the Tempus Agreements and the Transferred IP Assets to INC. If and to the extent LLC's transfer of the Tempus agreements (as relates to (a) above) and/or the transfer to INC of the right, title and interest in and to the Transferred IP Assets (as relates to (b)

above) was not fully effectuated, whether as set forth above, by operation of law or otherwise, then, in exercising the authority contained in Cal. Corp. Code Sections 17354 and or 17707.06, effective as of no later than December 31, 2013, *nunc pro tunc*, LLC hereby: (a) conveys, transfers and assigns the Tempus agreements to INC, and (b) assigns, transfers and conveys to INC, the entire right, title and interest in and to the Transferred IP Assets, the same to be held and enjoyed by INC and, as of December 10, 2014, by its successor and assign in Howmedica Osteonics Corp., without any reservation or limitation whatsoever. As of no later than December 31, 2013, *nunc pro tunc*, INC hereby assumes the conveyance, transfer and assignment of the Tempus agreements and accepts the assignment of the Transferred IP Assets.



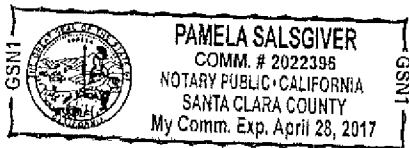
