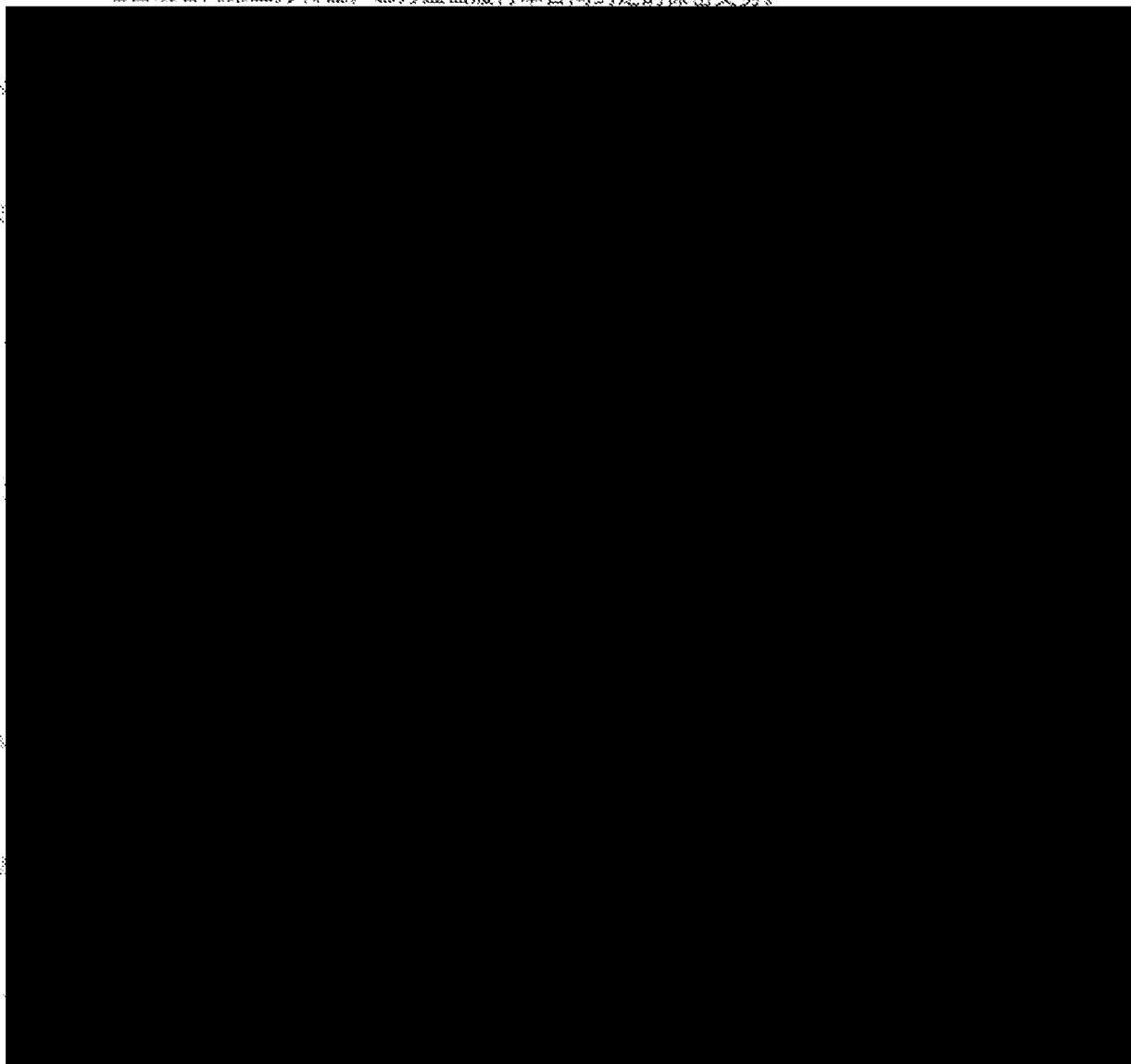




第36条 商业秘密的范围

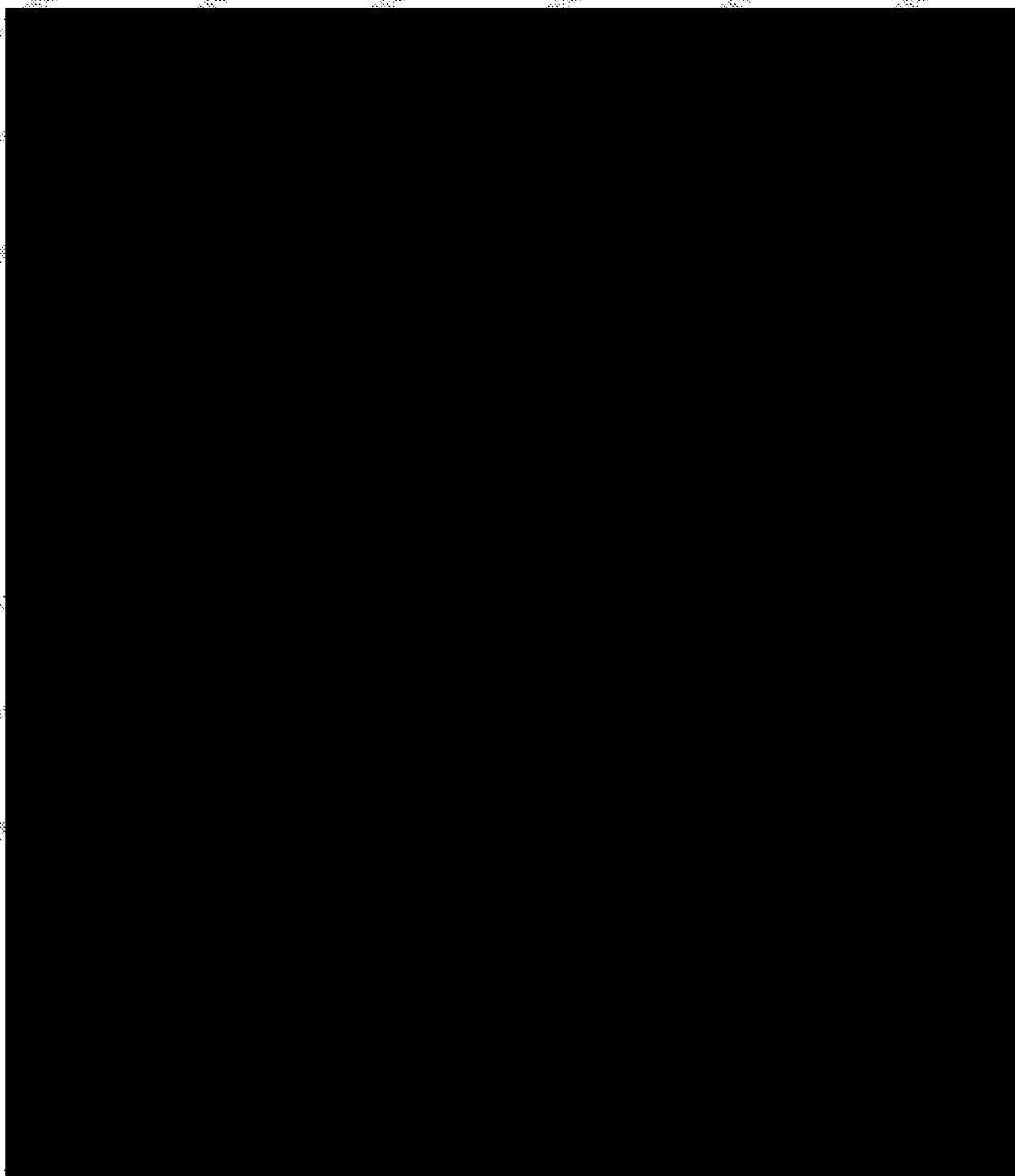

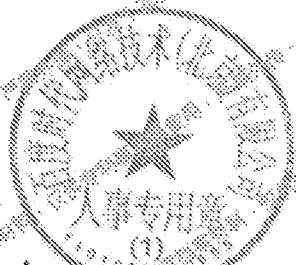
