## ASSIGNMENT

THIS AGREEMENT is made as of this the 29<sup>th</sup> day of August, 2012, by and between QUANTUM INTERFACE, LLC ("Assignee"), and REVELATIONS IN DESIGN, L.P. ("Assignor") (collectively "Parties").

Intellectual Property shall also include the following:

- a) Any patents on improvements of the above listed patents;
- b) any divisional, continuation, or substitute U.S. patent application based on those patents;
- c) any patents that shall issue on any improvements of the patents set forth above, and any reissues and extensions thereof;
- d) any patents and patent applications corresponding to each of the above described patents, and patent applications that are issued, filed, or to be filed in any and all foreign countries;

- e) any patents deriving from the above (including but not limited to patents of importation, improvement, or addition, utility models, and inventor's certificates), that shall subsequently issue therefore; and,
- f) any renewals, divisions, reissues, continuations, or extensions thereof.

Intellectual Property shall also extend to any copyrights ancillary or necessary to the creation or device embodied in the above patents, whether they be embodied in software or in any other medium.

## **2. TRANSFER OF RIGHTS.**

For good and valuable consideration, the sufficiency of which is hereby acknowledged, the Assignor transfers to Assignee any rights it may have in the Intellectual Property, whether they arise from being the Intellectual Property's creator, owner, licensee, or as a result of any law or statute anywhere in the World.

## **3. ADDITIONAL REPRESENTATIONS.**

Assignor will sign, upon Assignee's request, any documents needed to confirm the assignments made herein. However, the Parties agree that to the extent this document satisfies all legal requirements to effectuate an assignment of the Intellectual Property, no further documentation is necessary to do so as between the Parties.

Assignor will assist Assignee and its agents, upon request, in executing any documents requested necessary to evidence the assignments herein including U.S. and foreign copyright, trademark, and/or patent applications covering the Intellectual Property. Furthermore, they agree to sign any such applications, upon request, and deliver them to Assignee. Assignee will bear all expenses that it causes to be incurred in connection with such copyright, trademark, and/or patent protection.

## **4. WARRANTIES AND OBLIGATIONS.**

Assignor represents and warrants that it is the owner of the entire right, title, and interest in the Intellectual Property they purport to transfer by this Agreement, if any; that they have the right and power to make those transfers; that there are no other agreements with any other party in conflict with such transfers; and that they know of no prior art that would invalidate the patents made part of the Intellectual Property.

## **5. JURISDICTION/DISPUTES.**




