past, present and future infringements, the same to be held and enjoyed by the Assignee, its successors and assigns, from and after the Effective Date, as fully and entirely as the same would have been held and enjoyed by the Assignor had this Assignment not be made. The Assignee hereby requests the Commissioner for Patents of the United States Patent and Trademark Office, and any Official of any country or countries foreign to the United States authorized to issue patents on applications aforesaid, to record Assignee as the owner of such Patents and to issue all Letters Patent for said Patents in the name of the Assignee.

AND the Assignor covenants and agrees that it will use commercially reasonable efforts to execute or cause the execution of any further assurance of title to any of the Patents, and to, at any time, upon the reasonable request and at the expense of the Assignee, deliver, or cause to be delivered, any testimony in any interference, litigation or proceeding related thereto and execute, or cause to be executed, all papers that may be necessary or desirable to perfect the title to the Patents or any patent which may be granted therefor to the Assignee, its successors, assigns or any other legal representatives, and make, or cause to be made, to the extent possible, all rightful oaths or declarations, and do all lawful acts requisite for procuring the same therein, without further compensation, at the expense of the Assignee, its successors, assigns or other legal representatives.

AND the Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment.

AND this Assignment may be executed in multiple counterparts, each of which shall be deemed to be an original of this Assignment. Additionally, the Assignee and the Assignor hereby authorize their attorneys to collect the signature pages of each executed counterpart and to attach those signature pages to a single copy of this instrument, which single copy and attached signature pages together shall constitute an original of this Assignment.


